Eighteen months ago I became Mayor of Skipton, the greatest honour of my life. It has been a privilege to serve this town. During this period the overwhelming concern has been Covid: the people who have died, those who have been ill and those who still are ill; friends and relatives who cannot see their loved ones; and the many who are losing their jobs. We have become a lonely nation and my heart goes out to all. Throughout the pandemic, I have seen the people of Skipton pull together and look after the most vulnerable in our town.

Yet at the same time, over the past 6 years in fact, serious questions of governance have been raised at town hall. Tens of thousands of pounds have been spent on investigations. The outcome is that we have not been doing what is expected of us and there has been a breakdown of trust between councillors and staff. In principle, councillors make policy and officers try to make these policies work. It's all down to partnership. Councillors' political ties should not come first.

We need a new way forward to make sure that the problems of the past are not repeated. We need to be open, accountable and objective. And where we have failed we must acknowledge our failures, so that we can all feel better and stronger, which is what the town deserves. We can and we will do better. We have to work as a team, giving those living here in this superb town the future they deserve
