2425/143 <u>ITEM 10 – Finance reports</u>

Proposed by Cllr A Higgins, seconded by Cllr P Madeley, and resolved in favour to approve the schedule of payments, receipts, bank reconciliations, the budget to date, and to ring fence the remaining Community Grant funding for next year.

2425/144 ITEM 11 – Community Grant Applications

To consider the additional information for a grant application from the Community Sports hub recommended by the Finance committee to be received at Full Council to meet the request before the end of the financial year.

Proposed by Cllr P Madeley, seconded by Cllr W Feather, and resolved in favour to award the grant of £2000

To consider the additional information for a grant application from the organisers of Skipton Pride recommended by the Finance Committee to be received at Full Council to meet the request before the end of the financial year.

Cllr R Heseltine proposed to move this application back to the finance committee meeting scheduled for the 24^{th of} April, this was seconded by Cllr A Heseltine, and with 3 votes, the motion fell.

Proposed by Cllr A Higgins, seconded by Cllr B McDaid and resolved in favour to award the grant of £2000, 1 vote abstained and 1 vote was against, 12 in favour.

2425/145 ITEM 12 – Tarn Moor

The Chief Officer discussed the advice received from the Town Council solicitor. The Chief Officer advised that even though the solicitor had asked for any covenants members wanted to advise of it was prudent to be aware that there would be only one main covenant that they would try to secure, and that would be that the assets remained for the good of the people of Skipton. Proposed by Cllr P Madeley, seconded by Cllr W Feather, and resolved 7 votes in favour to give the Chief Officer delegated authority to continue liaising with the solicitors to complete the transfer and the confirmation of ownership of Bog Wood and to confirm everything at the next meeting.

2 abstentions, 7 in favour, Cllr R Heseltine did not take part in the debate and the voting whatsoever.

2425/146 ITEM 13 - Policies

2425/147 ITEM 14 – North Yorkshire Councillors

North Yorkshire Councillors were invited to update the meeting.

Cllr R Hesletine had no update to give.

Cllr D Noland advised the meeting of the lack of democracy within North Yorkshire County Councillors and that decisions were made ahead of council meetings, this was being investigated further. A VAS was being installed on Grassington Road using his locality budget and an active travel policy was being prepared for adoption.

Cllr P Madeley raised the issue of arranging the Gala and the obstacles that we faced with NYC.

Cllr L Morgan advised that Greatwood Community Center was in the process of planning an Easter Event.

Cllr C Nash updated the meeting of Selrap.

Cllr B McDaid gave the meeting an update on the recent Community Safety working group and an update of the CCTV that was planned to be installed at the bus station once the issue with NYC and the pruning of a tree that was

needed but was not being authorised, preventing installation of the additional camera. He also advised that the next litter pick was scheduled for the 28th March.
